- Captains will be called 20 minutes prior to play.
- All teams will participate in a seven team round robin best of 3 match; set 3, if necessary, will be to 25. No bracket play.
  - Times are tentative. Matches will continue as teams are ready.
- Warm-ups will be 6-6 for the first match and 5-5 for later matches.
- Teams will provide players to keep book, flip score, track libero, and line judge on Saturday; we hope to have younger players on Friday.
- During play, have your team ready to officiate at the conclusion of the previous match—we need to keep matches moving.

### Tie Breaker Process

- (1a) A team that beats in both sets all the other teams with which it is tied will finish ahead.
- (1b) A team that has lost in both sets to all of the other teams with which it is tied in both sets is placed behind.
- (1c) If teams are tied in set percentage and (1a) and (1b) do not apply, the team with the better point percentage will finish ahead of the other teams.
- (1d) If teams are still tied after (1a), (1b), and (1c), a one set playoff to 25 will occur.

**Warm-up balls will be provided. Warming up is NOT allowed outside of the arena!**
